

Sub: Special General Meeting / Extra-ordinary General Meeting & Executive Committee Meeting - Chennai - 11th March 2016

Mr. Chaudhary Avadhesh Kumar is misleading the Members by quoting Patiala House Court Judgment wrongly. The Court has not stayed our Meeting held at Chennai on 3<sup>rd</sup> March 2016.

The verdict of the Court is given below:

"In my considered opinion no ground for ad-interim injunction is made out at this stage. As prayed by counsel for plaintiff that plaintiff may be allowed to join the meeting. In these circumstances, defendants are directed to hold the meeting as scheduled for 03.03.2016 in the presence of plaintiff, President of the Federation as mandated in article 11 of the Constitution of the Federation".

The Madras High Court has allowed both the Meetings to go as given below:

"After hearing the submissions and perusing the relevant records, the Learned Judge was pleased to hold that the Meeting called by the Secretary General of Volleyball Federation at Chennai and the Meeting called by the President of Volleyball Federation at Nagpur could go on, however any decision taken in the Meeting, shall be subject to the final Orders in OA No.123 of 2016."
